

### **Note On Registration & Camping Fees:**

Your registration fees help pay for the costs associated with the fly-in including security, emergency services, rental equipment, and insurance amongst many expenses.

As part of their membership benefits there is **NO REGISTRATION CHARGE TO LIFETIME MEMBERS**. Guests of Lifetime members are subject to the per-person registration fee, and camping and bunkhouse fees **DO** apply to Lifetime members.

The registration fees charged for all attendees (members & guests) at the AAA/APM Fly-in is predicated on attendance of the entire five day fly-in event. Since many of the fly-in costs are constant for the event regardless of length of time a particular guest stays, we require an up-front payment of the total registration fee.

### **CAMPING & RV INFORMATION**

Tent camping under the wing of your aircraft is permissible, but please note, it must not overlap another aircrafts parking area, or extend into the taxiway.

**No vehicle parking allowed in any aircraft parking areas or taxiways.**

All RV and camping units must register at the AAA headquarters office. **No camping units will be allowed access prior to registration.**

**RV AREA:** *All travel trailers, 5th wheel trailers, toy haulers, Class A, B & C type RV's over 22' will be required to use the RV area on the South end of the airport.*

Adjacent to the S. campground it has good access and even terrain for easy parking. This area is close to the south shower house. While no electrical hookups are available, it is acceptable to operate a generator in this area. Please make certain your generator is properly muffled, quiet running, and shut them down after 10:30 pm.

Access is via the driveway on the East side of the runway behind the APM & Flymarket.

**Camping with electrical hookups, shower-house, dump station etc. is available in nearby Ottumwa at the Ottumwa Park Campgrounds. Call 641-682-1307 for more information.**

### **HANDICAPPED PARKING**

It is our policy to make every effort to assist those with handicaps or health problems to park in the areas close to AAA headquarters or the APM. It would help us help you in this regard if you write/call us in advance for the required car permit. You may request one from the registration office upon arrival; however, space is very limited and a permit is not assured in that case.

### **GOLF CARTS, ATV's etc.**

Due to a proliferation of various types of motorized vehicles, and underage drivers on and about the flightline and buildings, the use of golf carts, ATV's, scooters, jeeps or similar on the Antique Airfield grounds will be strictly limited to Fly-in officials, and those who show need (handicap sticker, license or similar), bring their own and provide proof of insurance for same.....

### **NO EXCEPTIONS !**

Members who are bringing golf carts need to provide the AAA with a certificate of insurance, with at least \$1,000,000 in liability coverage for bodily injury and property damage. The certificate also needs to name the Antique Airplane Association & Air Power Museum Inc., 22001 Bluegrass Road, Ottumwa, IA 52501 as an additional insured.

Security, storage, and safe operation of golf carts, etc., will be the owner's/operator's responsibility while on the grounds of Antique Airfield.
